## Scope and objectives

There is a constant push and pull in the chain of custody system between people who want to increase the rigor and coverage of the FSC CoC standard, and those who must implement an ever changing and increasingly complex standard. This creates a barrier to entry for FSC in many markets around the world, especially at the small business level.

## Innovative approach

FSC certification requires annual visits to ensure compliance with standards, but industries worldwide are in constant upheaval, especially small businesses. The staff tasked with certification compliance often may change between renewals or visits. Staff unfamiliar with the process will have more difficulty during audits, especially if working under the pressure of a five year expiration deadline. This leads to corrective actions and frustration with the FSC system overall. And that's not to mention someone completely new to the system that is simply trying to figure out what is actually being asked by the standard in order to get started.

The purpose of CoC certification is to be able to track each product back to the forest from which it originated, ensuring that it came from a responsibly managed forest. As would be expected, this process requires thorough documentation – and while complex, the process does not need to be onerous. With the right tools, any business – big or small – can succeed at becoming FSC® CoC certified.
